



### Payment

All fees must be paid in full for a student to complete enrollment. **Payment must be received by August 13, 2014 for a student to be financially approved prior to the first day of class.** When mailing a check, please print and return a copy of the statement with your payment, noting any adjustments.

Payment may be made by:

- Electronic check via the MyFurman portal or by calling the Official Payments phone number below. There is no fee for an electronic check payment.
- Paper check
- Credit Card— Visa, MasterCard, American Express and Discover card accepted. Call our service provider, Official Payments, at 1.866.836.3924. A service fee of 2.5% will be charged for a credit card transaction.

### Tuition

All students are charged the comprehensive tuition fee for up to 20 credits for fall semester. Requests for exceptions may be made by students who are financially independent as determined by the FAFSA, have documented medical or learning difficulties, or are considered fifth year seniors for billing purposes. The fifth year definition is detailed in the University Catalog Comprehensive Fee Policy at <http://www2.furman.edu/academics/catalog/Pages/default.aspx>

Students may request an exception to be charged on a per credit basis by completing an application through the Office of the Associate Academic Dean. Requests must be submitted no later than the last day of the course adjustment period (CAP). Students who are charged on a per credit basis during the academic year will be charged for any May Experience credits.

### Student Medical Insurance

Please check with your family insurance provider to be sure that the student will be adequately covered while away at school. Furman does not provide medical insurance for its students.

### Parking Permits

The parking permit fee will no longer be billed on the fall statement. Beginning this fall, students will register their vehicle or moped and pay the registration fee online. More information is available at <http://www2.furman.edu/sites/UniversityPolice/Pages/Parking-Information.aspx>.

### Meal Plans

Meal plans and food points for fall semester are as follows:

Unlimited meals/300 food points	\$2591
190 meals/350 food points	\$2232
160 meals/400 food points	\$2030
90 meals/425 food points	\$1375
75 meals/450 food points	\$1218

All residential students are required to have a meal plan.

First year students are required to take the Unlimited meal plan.

Second year students may take the Unlimited, 190, or 160 meal plan.

Third year students may take the Unlimited, 190, 160, or 90 meal plan.

Fourth year students may take the Unlimited, 190, 160, 90, or 75 meal plan.

Students living in the Vinings must have a minimum plan of 75 meals. Commuters may choose any meal plan, but are not required to have one.

Meal plans may be changed online via the MyFurman portal through **August 15, 2014**. **After this date, contact the Bursar's Office to make a change.** No changes will be made after August 28, 2014.

# Financial Aid - \*Remember to accept aid via the MyFurman portal\*

## Federal, State and Institutional Aid:

The online statement may reflect an "Estimated Financial Aid" entry that is being applied against your estimated charges. The award(s) listed represent the financial aid accepted via the MyFurman portal. If there are financial aid funds which were awarded yet do not show in "Estimated Financial Aid", please contact the Office of Financial Aid at [financial.aid@furman.edu](mailto:financial.aid@furman.edu), or by calling 864.294.2204.

A deduction for a loan origination fee of 1.072% for Subsidized and Unsubsidized loans and 4.288% for Plus loans is reflected in the estimated financial aid. The actual loan proceeds will be credited to the student's account upon receipt of funds from the lender.

### South Carolina Residents Only:

If you have a SC Tuition Grant, Palmetto Fellows, SC Life Scholarship or Hope Scholarship, you must complete, sign, and return an affidavit to the Financial Aid Office. This may be found on the Financial Aid website at [www.furman.edu/finaid/](http://www.furman.edu/finaid/)

### Outside Scholarships:

Students receiving funds from an outside source may deduct the amount of the scholarship from the statement balance only if payment or written commitment from the source is received by August 15.

An outside scholarship will be credited for the full amount to the semester in which it is received unless otherwise stipulated by the donor.

### Work Study:

Federal Work Study awards are not credited to the statement balance. Work Study recipients participate in a referral and interview process to obtain a job and are paid biweekly for hours worked. Students may apply earnings to their student account by bringing cash or check to the Student Business Center.

### ECSI Tuition Payment Plan:

If you participate in the ECSI tuition payment plan, you may deduct your August, September and October payments from the balance due. July 25th is the last day to enroll in a fall semester payment plan.

### Refunds:

All student refunds are made by direct deposit. Be sure to set up the "Non-payroll banking information" via the MyFurman portal in addition to making the refund request. Only one refund will be processed per student per semester. Please allow 7 to 10 days after drop/add for processing.
